

2. The documents produced by your school management along with affidavit, to District Education Officer (S.S.) and as per the recommendations of the Director Education Department (S.S.), Punjab, Chandigarh, after thoroughly considering the matter the Govt. of Punjab, it to grant the No objection Certificate under the terms and conditions mentioned below :-

1. If in future any complaint or fact being found during the inspection, that you have provided wrong information to the Govt. while obtaining No objection Certificate and application has been made according to that or you do not comply with the instructions issued by the Govt. of Punjab and also do not comply with the written terms mentioned in the affidavit, then in any of that event this No Objection Certificate shall be withdrawn.

2. The education of Punjabi in your school upto 10th standard shall be compulsory and C.B.S.E. New Delhi shall make it compulsory relating to these schools and also it is instructed that if it is not done so, this No Objection Certificate shall be withdrawn immediately.

3. That school management shall comply with the notifications strictly issued by Education Department, Govt. of Punjab under R.T.E. Act 2009 and rules framed by Govt. of Punjab under R.T.E. Act 2009.
4. That the school management after obtaining the affiliation with C.B.S.E. New Delhi shall pay the allowances to their teaching and non teaching staff as per Govt. employees, if it is not done so this No Objection Certificate shall be withdrawn immediately.
5. Your self and your management shall ensure that whenever any information is demanded by District Education Officer or any official of Education Department, then you shall submit the required information immediately and shall cooperate regarding that.
